NEW BUSINESS

Nominating Committee Status Report (Dave C.)

Active Nominating Committee met earlier this week; we have a few roles to fill:

- Secretary
- Membership Chair
- Social Chair
- Program Chair—put emphasis on helping to create programs, help the Social Chair, and help create educational programs
- Endowment Chair—suggested we may want a new board position called Finance Chair (to work on budget process) separate from Treasurer

(Michele) No more Endowment Committee?

(Joe) There would still be an Endowment Committee. The Finance Chair would be responsible for the Endowment Committee and process, as well as budgeting process

(Mike) So, a more formalized role for Finance Committee budget process?

(Kim) Also ensure knowledge sharing, in order to help communicate understanding of what can be a confusing process of budget and endowment

(Dave) We'd add a position but also take a position away

(Bill) So we'd still have the Endowment Committee?

(Joe) Yes, we need to have someone review and solicit requests

(Mike) Assumption is on Endowment side, we are changing the name, and on the budget side we are adding a more formal leadership position

(David) Need to be mindful of how we structure; the process was out of control, so we created a Finance Committee to take budget deliberations offline—observed this didn't always go smoothly in the past—we're formally institutionalizing process that we kicked in 3yrs ago to not waste time. I'm not objecting, just pointing out.

(Joe) Anyone have thoughts on what this would mean for the endowment process?

(Bill) My question is that, as Endowment requests come in (we basically have 3 that we have been dealing with each year), Finance can then request Endowment to review and comment; don't need another leadership position, just need a way to manage

(Dave) Once Finance Committee is established, they will also work on Endowment; Finance is busy December through February

(Bill) There's already procedure in place for when requests are due to come in and when they get approved; the time in between will be for Endowment to review requests

(Michele) I don't want to eliminate Endowment Committee, it was born for a reason

(Joe) That's not what we are doing—we'll still have the committee, just not a chair. Does head of Finance become Endowment Chair?

(Mike) We could call it Finance Chair with Budget Committee and the Endowment Committee

(Steve) You need the Finance Chair to be the leader of the Endowment Committee; by combining them we are adding more consistency

(Joe) Finance Chair would be responsible for budget and leading Endowment Committee; so, the Endowment Committee wouldn't change except its leader would now be the Finance Chair

(Ingrid) What if there's a conflict? What if Endowment Committee disagrees with Finance Chair?

(Alex) We vote on requests as committee

(Michele) The Endowment committee votes whether to submit request, not whether to approve

After long discussion it was agreed upon to eliminate the Endowment Chair and create a Finance Chair.

Mike M. moved, and was seconded, for the coming committee 2020 fiscal year to eliminate the position of Endowment Chair and to create a new position of Finance Chair, who's role is to lead both the Budget and Endowment Committees.

Unanimously APPROVED

Send any chair suggestions/nominations to Dave C. and he will vet them out.

Finance Committee Mid-Year Report (Jose, Joe)

(Joe) I raised the question of who is eligible for reimbursement for Fall Gathering; answer is Chapter Chair, Vice Chair, and OLDC Chair

(Joe) State of current finance relative to budget:

- Income stream is on plan
- We are short because haven't received all income yet (not due)

(Jose) We have a shortage of cashflow due to timing

(Joe) Expense is way under plan (see treasury report)

(Joe) I will send a request for what spending will be; how you plan to spend; have any ideas on how to spend excess funds; may have unspent funds this year and will be taken into account next year; price we pay is we don't get things done we thought were worthwhile; if we have a short fall we dip into endowment and this money could be used for other things (outreach, etc.); it's important we budget well

(David E.) I would rather someone not spend than say "I should spend the money or Joe will take away next year"

(Joe) If you under budget and then discover midyear you need more, come to the Executive Committee and request—we almost always find budget

(Joe) There's a requirement from the club that all chapters must manage funds/financial operations, not only of chapter, but their committees For us, this means that the Midstate Trail Committee and the Chapter need to get together and come up with a plan to manage funds in a way that satisfied the requirements.

(Kim S.) The club needs to tell us what they want

(Joe) I will follow up with you (Kim S., Steve Crowe, Don H.)

(Jose) We had a treasurers meeting because new regulations came out; they need to give training, etc.; they're working on it

(Paul) We formed a committee (Janice, Neil, Debi); all had input and there were a number of iterations; we are at the point now where we are using them; I'm not sure if we're required to approval/vote on them; they are also intended to be shared with potential leaders, so they know what is expected of them

After significant discussion, there was agreement that the document needed another round of inputs, and that wanted to bring the next version to a vote by the EC.

(Joe) We're not going to review or edit now; send comments to Paul; can deliberate and get all in agreement by Sept 1

(Paul) comments in by Aug 15, out Sept 1, vote Sept 25th

Planning Team Read-out: Conservation/Partnerships (including TrailsFest recap) (Steve, Shalin)

Our group spent time discussing partnerships with the GWLT, colleges and the Eagle Scout Candidate that Dave Cole invited.

Change is constant with College groups. Greg Doerschler is the GWLT Volunteer working with colleges. Transportation is the key to getting college students together.

We discussed a partnership for the City of Worcester's Earth Day Clean-up on April 27th. A conflict developed with the DCR's Park Serve Day and our volunteers went to Wachusett.

We talked about continuing the conversation about Wildness and Wilderness Ethics with the Waterman Fund and their books. Upcoming events are the Alpine Stewardship Gathering Oct 25-27 and a program at Plymouth College.

We talked about a TrailsFest event and although Shalin was not part of this Group he stepped up develop a team that to produce an extraordinary signature event.

- This event took around 1000 volunteer hours to produced. I estimate that Shalin put in 200-300 hours, I had about 100. 20 other committee members, plus trip leaders and volunteers for the day of the event.
- Now we need to examine what went right, what went wrong and what we could do better.
- Shalin couldn't be here due to job but sent email saying he is happy to lead TrailsFest Committee for 2020

Looking ahead to 2020 we need to do a better job of working all year. Last year I worked by myself to get some things in place before our committee meetings started. We were still too late as other organizations had already made plans for NTD. Shalin did an excellent job of getting feedback from those involved to help with planning for next year.

Volunteers Needed this Fall:

- TrailsFest Chair: likely to be Shalin again, should delegate more of the tasks to lighten the load for future chairs.
- Coordinator for Land Trust Partners and other Outdoor Groups
- Coordinator for Commercial Sponsors Alex Molnar did some of this as AMC Staff. Consider Subaru that gets people outside, Banks and Corporations.
- Site Coordinator to work with Wachusett Staff.
- Activities Coordinator need for next Spring

Consider other events with Wachusett Ski area and REI. Last Year REI hosted a 'Pray for Snow' event at Wachusett in December. Not sure how their New Hampshire store will affect the location this year.

All want to have this event next year

(Mike) At Nominating Committee meeting when we were talking about Programs Chair, we discussed Vice Chair being responsible for Trails day instead of picnic, and then Programs doing other things

(David) Relationship good with Wachusett going forward?

(Steve) Yes. Jeff had mentioned when we first met 2 years ago, he had interest in 'every kid outdoors'; would like to get to the point where we can fundraise at TrailsFest to replace the \$5,000 we get from Endowment for YOP; could do more with REI "pray for snow"; going forward would like to see Shalin break up job more; coordinator for land trust and other groups (e.g. commercial sponsors)

(Joe) Did Shalin publish results of survey? Want to make sure they got out. (Steve C) Yes
