- Chapters Committee Retreat Update
 - Wendy D There is a spinoff sub-committee called the High Performance Team Group. This group's next focus is aligning the Worcester Chapter's goals with the AMC Club goals.  - Alex M mentioned that there is a guidelines document regarding how/who we pursue partnerships with and giving money thru grants. Maybe from the Endowment Committee that handles these requests?
 - Mike P says he could be the liaison for Clinton Greenway trust going forward for their projects
 - Charlie A suggests checking guidelines for what AMC supports not buying land—check what the guard rails are. He offered to help if needed.

7:00 PM — New business (30 min)

- AMC Budget Deficit Chapter Reserves Request Update
 - o Chris P Shared info with respect to our budget and deficit with ??? (need name from Chris)
 - Charlie A– Said that excess cash reserves used in the 2024 budget for projects is to be voted on formally by the board in the next couple of weeks. Instructed the Chapter to do the budget as usual and use cash reserves to cover things. Says that historically we haven't spent everything that was put in the budget.
 Whatever isn't spent from the Endowment is rolled over to excess reserves.
 - Christine C we have commitments to things that are outstanding (get help from Christine on summary of this discussion topic)
 - o David E Confirmed with Charlie A that everyone's excess reserves are being zeroed.
- Open Positions Update Kim B
 - Trails Chair (new) Kim is talking with Eric Eric has someone interested and he is experienced. His name is John Mangano. Alex M, Rob G and Zenya M also knew him and all are enthusiastic.
 - Motion to accept David E; second Zenya M. Vote taken AIF.
 - o Programs, Family, Social still have open positions.

 - Planning Committee mtg 1/27/24, 9A-1P
 - Memo sent, majority of members are available 1/27. We will meet from 9a-1p at the Auburn Middle School Kickoff mtg 2024.  - AMC Annual Summit January 20 21, 2024

Mike P says some reasons why they were over budgeted is because a certain number of people/costs were allocated to Sawyer Training and WOFA and then the Sawyer training wasn't available and not as many people went to WOFA—it is a bit of an unknown.
 - Vote taken AIF.
